IN 2015, THE HOPE CENTER PROVIDED A WEEK OF GROCERIES FOR OVER 95,000 INDIVIDUALS STRUGGLING TO FEED THEIR FAMILIES, INCLUDING APPROXIMATELY 50,000 CHILDREN. IN ADDITION, DURING THANKSGIVING AND CHRISTMAS OVER 1000 FAMILIES ARE "ADOPTED" AND RECEIVE TURKEY, DRESSING AND ALL THE TRIMMINGS FOR A WONDERFUL FAMILY MEAL. PRIOR TO CHRISTMAS, WE PROVIDE TOYS TO THE PARENTS REGISTERED FOR FOOD ASSISTANCE SO THEY CAN PLAN "SANTA" IN ORDER FOR THEIR CHILDREN TO HAVE THE JOY AND SURPRISE THAT SHOULD COME ON CHRISTMAS MORNING.

WE OFFER OSHA FORKLIFT CERTIFICATIONS AND IN 2013 WE ADDED CUSTOMER SERVICE AND HOSPITALITY IN THE CULINARY ARTS CAREER FIELD. STUDENTS EARN SERVSAFE FOOD MANAGER CERTIFICATION PLUS THE SKILLS NEEDED TO WORK AS A SERVER IN THE FOOD INDUSTRY. IN ADDITION, CAKE DECORATING AND GARDE MANAGER TRAINING HAVE BEEN ADDED TO THE SCHOOL OF HOPE. ALL CLASSES OFFERED BY THE SCHOOL OF HOPE ARE APPROVED BY THE TEXAS WORKFORCE COMMISSION AND JOB PLACEMENT ASSISTANCE IS PROVIDED AFTER GRADUATION WITH OVER 80% OF APPLICANTS BEING PLACED IN NEW EMPLOYMENT.
